Bundelkhand Sahakari Dugdh Sangh maryadit, Sagar is a milk union of M.P State Cooperative Dairy Federation Ltd., Dugdha Bhavan, Habibganj, Bhopal (MPCDF), for its affiliated milk unions intends to purchase plastic jars of 5 ltr and / or 15 kg capacity with printed artwork given by BKDS, Sagar with in- mold Labeling (IML) technology for packing of ghee at the dairy plants located at Sagar (Bundelkhand), thus, strictly adhering to the quality benchmarks and technical specifications prescribed in the etender.

The jar is required for filling Ghee prepared from fresh cream and butter having fat-99.7% and moisture 0.3% with shelf life of minimum 6 month from date of packing, done at the temperature of **45** degrees centigrade.

General Terms & Conditions of Tender

Bundelkhand Sahakari Dugdh Sangh maryadit, Sagar is a milk union of M.P State Cooperative Dairy Federation Ltd., Dugdha Bhavan, Habibganj, Bhopal (MPCDF), for its affiliated milk unions intends to purchase plastic jars of 5 ltr and / or 15 kg capacity with printed artwork given by BKDS, Sagar with in- mold Labeling (IML) technology for packing of ghee at the dairy plants located at Sagar (Bundelkhand), thus, strictly adhering to the quality benchmarks and technical specifications prescribed in the e- tender.

The CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar solely reserves the rights to accept or reject, partially or fully, any or all tenders without assigning any reasons thereof.

1.0 **DECLARATION:**

- 1.1 Mere submission of a bid by a tenderer itself implies that he/she has read all the instructions, terms and conditions stipulated in the tender and has completely made himself / herself aware of scope, quality & technical specifications of "IML pinted (PPCP) Food Grade jars for packing of Ghee" with technology/features, supplies to be made at the defined destinations and, have fully satisfied himself / herself with all related bindings that were expected from him / her through conscious participation.
- 1.2 SAMPLE OF JAR: -Successful tenderer submit sample (as per tender specifications) of both ghee jar before rate approval.

2.0 EARNEST MONEY DEPOSIT (EMD):

- 2.1 The tenderer would deposit online EMD of Rs 25,000 /- (Rupees Twenty-five Thousand only) for 05-liter jar and Rs 35,000/- (Rupees Thirty-Five Thousand only) for 15 kgs jar. In case, the bidder opts to apply for both the items then the total value of EMD shall be Rs. 60,000 /- (Rupees sixty Thousand only).
- **2.2** In no case, bidder will be allowed to submit EMD physically.
- **2.3** Any tender not accompanied with EMD shall be rejected summarily.
- **2.4** Earnest Money Deposit of disqualified tenderers will be returned from the etender site automatically following e-tender norms of MP.
- **2.5** The EMD of successful tenderers will be released only on completion of supplies, testing and warranty thereby covering replacement and after one year of rate validity period.
- 2.7 No Interest will be paid on the earnest money deposit for the period retained at BKDS, Sagar.

- **2.9** EMD exemption will be given to the supplier of MSME registered in M.P. State only.

3.0 TENDER PERIOD:

3.1 Price bid approved shall be valid for a period of one year from the date of rate approval. Its validity can be extended up to additional six months on same terms & conditions.

4.0 BIDDER ELIGIBILITY CRITERIA.

- **4.1** The tenderer should possess PAN, GST.
- **4.2** The bidder should have a minimum business turnover of Rs 1.00 crore for units dealing with 05 ltr jar, Rs.1.00 crore for units dealing with 15 kgs jar, Rs. 2.00 crore for units dealing with combined production of 5 liters and 15 kgs pack in any of the last 3 years or (2019-20), (2020-21) or 2021-22. It will be confirmed through Financial accounting records duly verified by Chartered Accountant.
- **4.3** The Manufacturer/ Distributor/ Supplier / dealers should ensure to have adequate financial and technical competence and should be willing to fulfill the demand, if selected.
- **4.4** Any bidder having blacklisted for any reason, by any co-operative dairy organization in India, should not apply.

5.0 TENDER SUBMISSION:

- **5.1** The tenderer will have to upload all the technical bid documents online mandatorily.
- **5.2** The Financial bid shall mandatorily be submitted online only (refer Schedule IV). In no case the financial bids would be entertained if submitted physically by any bidder.
- **5.3** The EMD will be Submitted online only.
- **5.4** The Financial bid of any bidder will be opened only after successfully qualifying the Technical bid.
- **5.5** The tenderers should clearly indicate the current contact mailing address, telephone, mobile, e-mail, PAN and GST number. Any change in the address should immediately be communicated to the Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar.
- **5.6** The bidder should submit detailed technical specifications of the items /material being offered with related guarantee/warranty condition.
- **5.7** The tenderer must submit **Trading Account** duly certified by charted accountant.
- **5.8** Negligence / Carelessness on the part of tenderer in filling the tender form/quoted price shall cease his/her rights to withdraw from the tender once opened.
- **5.9** The tenderer shall submit the tender in the prescribed form only. Conditional tenders are liable for outright rejection.

- **5.10** No Individual or firm shall be allowed to submit more than one tender under different names.
- **5.11** In the event if any firm that was functioning individually and for obvious reason has merged with another firm then in such cases the firm should submit a copy of valid registration from competent authority.
- **5.12** Canvassing or offer of an advantage or any other measures of inducement by any person for influencing acceptance of his / her Tender will be a serious offence under laws of India. Such action will solely result in the rejection of his / her Tender.
- 5.13 The tenderer cannot sublet or assign wholly or partially the approved Supply order to any other party/parties. In any case, if it is found so, then the assigned Supply order will immediately be cancelled and the party will be solely liable for black listing by BUNDELKHAND SAHAKARI DUGDH SANGH MARYADIT, SAGAR.
- **5.14** A copy of manufacturing license is to be attached with other technical bid documents of tender. The authorized dealers / channel partner etc. dealing with the item will have to attach a copy of authorization certificate of the concerning manufacturer.
- **5.15** The tenderer will have to provide all the details of his/her unit in the forms **A** and **B** given at Schedule-III.
- **5.16** The CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar solely reserves the rights to accept or reject, wholly or partially, the tender / awarding purchase order without assigning any reasons thereof.

6.0 Prices:

Prices offered by the tenderers should be firm and free from all escalations and shall be valid at least for a period of 12 months from the date of approval of rates. BKDS will have the right to extend the validity of the tender approval by 3 months. We would communicate our rate approval within 60 days of opening of tender. If any

tenderer wishes to offer the rate subject to <u>PRICE ESCALATION</u> <u>CLAUSE</u> of raw materials, they may do so by clearly indicating in the tender rate form –A(Point no.16). In case of a tenderer opting for offering prices subject to PRICE ESCALATION CLAUSE of raw materials (i) then the tenderer shall have to submit the current price of the raw materials as on the date of tender along with sufficient authentic proof from the manufacturer of the raw material. the successful/approved firm will have to submit revised prices of raw materials with sufficient authentic proof from the manufacturer of the raw material whenever revision takes place. accordingly, the approved prices of the materials shall be revised upwardly or downwardly to the extent of the raw material component of the material.

- 6.1 The tenderer is required to quote price of plastic jars of 5 ltr and/or 15 kg capacity printed with In Mold Labeling (IML) technology with all taxes.

 Tenderer can apply for both or single type of jar.
- **6.2** The lowest rate so finalized will be inclusive of all taxes and FOR as given in scope.
- **6.3** Only Rate approval will be given by Bundelkhand Sahakari Dugdh Sangh maryadit, Sagar after tender finalization and receiving of sample of jar as per tender described specification.

7.0 MODE OF DISPATCH:

- **7.1** The material to be supplied by successful tenderer shall be dispatched to the sagar dairy plant under intimation to the purchaser. Depending upon the type of material, the supplier shall ensure to carry out proper packaging/ crating to avoid damages during transit.
- **7.2** The volume of supplies for the material is for one year.
- **7.3** Wharf age /Demurrage etc, on account of dispatch or incorrect or delayed dispatch of material shall be the responsibility of supplier and shall be recovered from the supplier bill.
- **7.4 Delivery schedule:** The material required falls under top most urgency and schedule of delivery of ghee Jars should start immediately after one month from the award of Purchase order.

8.0 LIQUIDATED DAMAGES:

8.1 If for any reason the successful tenderer refuses to accept purchase order / fails to comply supplies as per purchase order / backs out at a later date for no reason, then the respective milk union(s) reserves the right to cancel the order and make purchases from other available alternate sources, at the risk and cost & expenses of the defaulting L1 tenderer/supplier and Rate contracting firms could be blacklisted for all future dealings. Also, the EMD/Security deposit would be

forfeited by BUNDELKHAND SAHAKARI DUGDH SANGH MARYADIT, SAGAR. Such defaulting party shall be liable for legal actions governedunder approved Stores & Purchase rules of MPCDF.

8.2 Once firm delivery schedule is fixed then it shall be strictly adhered by the supplier. In case of supplies and services are not fulfilled as per the schedules, the liquidated damages may be charged on the goods/services not so delivered as under.

8.3 If L-1 tenderer refuse / back out from agreement or supplier then L-2 may give chance to supply in L-1 rates if so then L-2 will be treated as successful tenderer.

9.0 MATERIAL DESCRIPTION:

- **9.1** Specification of the packaging materials has been given in Schedule II.
- **9.2** The bidder will ensure to submit a brochure carrying complete specification, manufacturing details of raw materials and batch wise testing/quality report of supplied jars. Report of virgin Raw material which is used for manufacturing of jar.
- **9.3** Testing reports regarding the quality of the Packaging materials must be available with material for the supply of each lot / batch from CIPET or equivalent govt. organization's NABL accredited lab.
- **9.4** BUNDELKHAND SAHAKARI DUGDH SANGH MARYADIT, SAGAR has authority to check the quality of supplied material at any time from third party. (CIPET or equivalent govt. organization lab).

10 INSPECTION:

- 10.1 All the materials are subjected to inspection at our location / unit / office before its acceptance. If jars are rejected due to any defect/ transit damage, the report of our inspector in this respect shall be final and no correspondence on the subject would be entertained. The rejected jars should be removed from our premises by the tenderer within 15 days after receipt of our inspection report, failing which the same shall be returned to the supplier at his risk and expenses.
- 10.2 Bundelkhand Sahakari Dugdh Sangh Maryadit officers may visit the manufacturing unitand order may be placed after satisfactory report from them.
- 10.3 No manufacturer/Supplier should produce or supply the Sanchi Ghee jars or lid or any other part for any duplication of jars of same specification and design. If in case the issue of duplication of the jars is found, contract will be terminated

immediately and party will be solely liable for blacklisting by BUNDELKHAND SAHAKARI DUGDH SANGH MARYADIT, SAGAR and legal action shall be taken.

11.0 PAYMENT:

- 11.1 Bill will be raised by the supplier on the basis of base price and GST separately but total of rate must be equal to the rate approved in the tender.
- 11.2 Payment shall be released on safe receipt and filling of jars at the site subject to acceptance after inspection by the concerned purchaser within 30 days.

11.3 No supply to unauthorized person/firm:

Tenderer will never supply sanchi brand ghee jar to unauthorized person/firm else it will be treated as offence for duplication of sanchi brand ghee and such supplier will be liable for all legal action and blacklisting and EMD shall be forfeited for which he shall be solely responsible.

12.0 No deviation clause:

No deviation will be accepted in any mandatory terms & conditions and specifications of the tender. In case any deviation is found after opening of technical bid and commercial bid tenderer will be debarred from the tender process and Chief Executive Officer, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar reserves the right to reject any or all tenders on the basis of any deviations.

13.0 SIGNING OF AGREEMENT:

13.1 Successful tenderer shall sign into a agreement with Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar on non-judicial stamp paper of Rs1000 /- within **15** days after receipt of rate approval order. Draft of agreement will be providing by Dugdh sangh to the successful tender.

14.0 EMD Forfeit & Black Listing:

If successful tenderer fails to execute the agreement and fails to supply the material then, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar will reserve the right to forfeit the EMD and blacklist the bidder and all his firms.

15.0 DISPUTE ARBITRATION & FINAL AUTHORITY:

- **15.1** In the event of successful tenderer failing to accept or / and execute the Supply order, then the decision of the CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar shall be binding on the tenderer.
- **15.2** If the successful tenderer fails to accept or execute the work order or any dispute arising thereof, it shall be resolved through arbitration thus following Arbitration Act 1996. The award of the Arbitrator shall be binding on both the parties involved in the trade.
- **15.3** The venue for deliberating all such disputes shall be Sagar, MP.
