

SCHEDULE - I

General Terms & Conditions of Tender

Bundelkhand Sahakari Dugdh sangh Maryadit, Sagar is a union Of MP State Cooperative Dairy Federation Limited (MPCDF), Dugdha Bhavan, Habibganj, Bhopal (MP) invites online tenders through MP e-procurement portal www.mptenders.gov.in from manufacturers / or their authorized dealers for supply, Installation and commissioning of Lined Carton Ghee Packing Machine for 200 ml ghee variant at dairy plant Sagar adhering to the quality benchmarks and technical specifications prescribed in the tender.

The CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar solely reserves the rights to accept or reject, partially or fully, any or all tenders without assigning any reasons thereof.

1.0 <u>DECLARATION</u>:

1.1 Mere submission of a bid by a tenderer itself implies that he/she has read all the instructions, terms and conditions stipulated in the tender and has completely made himself / herself aware of scope, quality & technical specifications of **Machine** with technology/features, supplies to be made at the defined destinations and, have fully satisfied himself / herself with all related bindings that were expected from him / her through conscious participation.

2.0 EMD & RATE VALIDITY PERIOD:

- 2.1 The tenderer would be required to deposit of Rs 50,000 /- (Rupees Fifty Thousand only) online as Earnest Money. EMD submitted physically or by any other means by any bidder shall not be entertained.
- 2.2 Price bid if approved shall be valid for a period of one year from the date of rate approval.

3.0 TENDER SUBMISSION:

- 3.1 A tenderer will not submit more than one tender. No Individual or firm shall be allowed to submit more than one tender under different names.
- 3.2 The tenderer will ensure to clearly indicate his / her position / capacity in the bidding firm in signing the tender and related documents.
- 3.3 The Bidder should posses a valid GST registration certificate, PAN income and income tax return of previous two years. (2021-22,2022-23)
- 3.4 The tenderer has to submit Earnest Money Deposit (EMD) of Rs. 50000/(Rupees Fifty Thousand only) online only. In no case the other modes of EMD deposition would be entertained if submitted physically by any bidder.
- 3.5 The tenderer will have to submit the technical bid papers online only.

4.0 OTHER PRE-REQUISITES:

- 4.1 The tenderer should clearly indicate their mailing address, telephone, mobile, fax, e-mail, PAN and GST number. Any change in the address should immediately be communicated to the CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar for exchanging future correspondence.
- 4.2 Negligence or carelessness on the part of the tenderer in filling the tender form / price / quote etc. shall not lend him / her any rights to withdraw from the tender once it is opened.
- 4.3 The tenderer shall submit the tender in the prescribed form only. Conditional tenders, in any case, are liable for outright rejection.
- 4.4 The tenderer will ensure to seal & sign at the bottom of each page of the tender document in token of their acceptance to the terms and conditions of the tender.
- 4.5 The tenderer cannot sublet or assign wholly or partially the approved supply order to any other party/parties. In any case, if it is found so, then the assigned supply order will immediately be cancelled and the party will be solely liable for black listing by **Bundelkhand Sahakari Dugdh Sangh Maryadit**, **Sagar**.
- 4.6 A copy of manufacturing license is to be attached with other technical bid documents of tender. The authorized dealers / channel partner etc. dealing with the item will have to attach a copy of authorization certificate of the concerning manufacturer.
- 4.7 The tenderer will have to provide all the details of his/her unit in the forms given at Schedule-III.

5.0 <u>EARNEST MONEY DEPOSIT (EMD)</u>:

- 5.1 Any tender not accompanied with EMD shall be liable for rejection. Earnest Money Deposit of unsuccessful tenderers will be returned from the procurement side automatically as per the MP e tender norms.
- 5.2 The EMD of the successful tenderer will be released only on completion of supplies, testing and warranty thereby covering replacement and after one year of rate validity period.
- 5.3 No interest will be paid on the Earnest Money for the period during which (the EMD) lies in deposit with the CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar.

6.0 PRICES:

- 6.1 The tenderer is required to quote price of machine (FOR basis Main dairy plant, Sagar)
- 6.2 Correction of errors, if any, in the tender document should be duly followed with

- initials/signature of the tenderer / firm at the places of every such correction made.
- 6.3 The prices offered by the tenderer should be firm and free from all anticipated escalations. In the dare validity period of one year for the date of tendering of opening of tender.
- The lowest rate shall not be the only criteria in particular for awarding the tender until the supplier satisfies the stakeholder specifications and requirements.
- 6.5 The lowest rate so finalized will be inclusive of Machine cost with one year warranty and consumable parts.
- 6.6 After successful opening the tender, rates will be finalized and approved of rates will be given by Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar within 30 days.

7.0 MODE OF DISPATCH:

- 7.1 The machines to be supplied by successful tenderer shall be dispatched to the main dairy plant, sagar under intimation to the purchaser with proper packaging / crating to avoid damages during transit.
- 7.2 Wharfage / demurrage etc. on account of incorrect or delayed dispatch of material of documents shall be the responsibility of supplier and shall be recovered from the bill.
- 7.3 <u>Delivery schedule: However,</u> the packaging machine should be supplied in the stipulated time which shall be within **two months** from the date of purchase order.
- 7.4 The supplier shall bear the insurance charges of the equipments during transit.

8.0 **LIQUIDATED DAMAGES:**

- 8.1 If for any reason the successful tenderer refuses to accept purchase order / fails to supply as per purchase order / backs out at a later date then the respective milk union(s) reserve the right to cancel the order and make purchases from other available alternate sources, at the risk and cost & expenses of the defaulting tenderer supplier and supplying firm could be blacklisted for all future dealings. Also the EMD/Security deposit would be forfeited by **Bundelkhand Sahakari Dugdh Sangh Maryadit**, Sagar.
- 8.2 Once firm delivery schedule is fixed then it shall be strictly adhered to by the supplier. In case of supplies and services are not fulfilled as per the schedules, the liquidated damages may be charged on the goods/services not so delivered as under.

8.3 After supply of the machine, the supplier should ensure that the test trials will be done within 07 days of the supply by the expert service engineer and ensure starts smooth operation by guiding and providing complete training and details of the operation to the operator / concern person.

9.0 MATERIAL DESCRIPTION:

- 9.1 Specifications of the packaging machine are given in Schedule-II. If in case any amendment required will be loaded in at MP tender's website www.mptenders.gov.in and official website www.sanchidairy.com
- 9.2 The supplier has to install and give satisfactory trial run of the machines for 200 ml ghee variant. Packaging material provided by BKDS for trial.
- 9.3 Suppliers has to provide all the consumable parts of the machine for one year

.

10.0 **INSPECTION**:

10.1 Packaging machines after delivery are subject to inspection at dairy plants before acceptance. If machines are rejected due to any defect, deficiency transit damage or wrong supply, the report of our inspector in this respect shall be final and no correspondence on the subject would be entertained. The rejected machines should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed off in auction and the proceeds, if any, less expenses shall be credited to the suppliers account.

11.0 PAYMENT:

11.1 70% payment shall be released on safe receipt of machines at site subject to acceptance after inspection by the concerned section/department. The balance 20% payment shall be released only after completion of installation and successful trial run of machines and rest 10% payment will be released after one year from the date of commissioning.

12.0 AGREEMENT:

- 12.1 Signing of MOU by incorporating the required term and condition will be done between successful tender and the Chief Executive officers of Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar.
- 12.2 If the successful tendering firm / its authorized dealers commit breach of any of the conditions of tender even at a later date then the CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar reserves the right to cancel the award and authorize to purchase the material from other sources at the risk of the firm.

13.0 DISPUTE ARBITRATION & FINAL AUTHORITY:

- 13.1 It should be clearly understood that in the event of a successful tenderer failing to accept or / and execute the supply order, then decision of the CEO, Bundelkhand Sahakari Dugdh Sangh Maryadit, Sagar in this respect will be final and binding on the tenderer. For all disputes, the venue shall be at sagar, MP.
- 13.2 It should be clearly understood that once agreement is executed, the successful tenderer then in the event of the successful tenderer failing to accept and execute the work order or any dispute arising thereof, then the content thereof shall be referred to the Arbitrator as per the Arbitration Act, 1996 and the award shall be at the discretion of the arbitrator.
- 13.3 For all disputes, the venue of the jurisdiction shall be at Sagar, MP.

<u>Technical Specifications for Lined Carton Ghee Packing Machine</u>

1. Design Parameters

- 1.1 Capacity
 - I. 37 40 Packs per minute for 200 ml
- 1.2 Filling Accuracy for different SKU's will be as follows:
 - I. ±1.50% for 200 ml
- 1.3 The operation of the machine will be as follows:
 - Carton Feeding
 - II. Heat sealing of bottoms of liner
- III. Gluing, Coding and closing of carton bottom
- IV. Filling of product using Piston Filler
- V. Full sealing of liner
- VI. Gluing of top flap of carton and closing of the same.
- VII. Discharge of carton at the Ejector Unit
- 1.4 Leakage Free of Leakers
- 1.5 Utilities
 - I. Compressed air: up to 4 CFM at 6 kg/sq.cm
 - II. Electric power: 8 kWH, 415 V, 3 Phase, 50 Hz AC supply.

1.6 MOC

- I. All product contact parts should be fabricated from AISI 304 stainless steel.
- II. Main machine body to be cladded using AISI 304
- III. All non-SS surfaces are to be de-rusted, degreased and then coated with two coats of anticorrosive primer followed by two coats of PU paint with grey colour.

2. Unit Functions

Carton Release: Pre-formed carton blanks will be place in the Carton magazine. The carton carrying arm

will one by one be fed into the Carton Holder using Vacuum.

Coding: Inkjet coder installed on the machine shall then code the bottom / top flap

Bottom Sealing: The Carton will then be formed, the liner will be stretched and sealed in the bottom

sealing unit.

Bottom Minor: The bottom minor flaps will then be folded in the flap folding unit

Flap Folding following the major flap that shall be folded using guides.

Bottom Gluing Once the minor flaps are folded, glue is applied on the inside of the bottom major flaps

followed by major flap folding using guides installed on the machines

Filling Unit: One servo driven liquid filler installed at the designated filling station shall fill the

required quantity of the product. The filler hopper capacity shall be 50 liters.

Top Sealing: Once the product is filled, liner protruding at the top will be stretched and sealed in the

top sealing unit.

Top Minor: The top minor flaps will then be folded in the flap folding unit flap Folding following the major flap that shall be folded using guides.

Top Gluing: Once the minor flaps are folded, glue is applied on the inside of the top & bottom

major flaps followed by major flap folding using guides installed on the machines

The cartons are then ejected from the machine on to a 7 feet long pressure conveys which facilitates the flap sealing by applying pressure at the top and bottom of the formed and filled carton.
