Bundelkhand Sahakari Dugdh Sangh Maryadit Sagar invites online tenders (Two Bid System) for Supply, Installation & Commissioning of Refrigeration system for blast freezer chambers of 100 MT capacity (50 MT- 2 Compartments) butter storage in Main dairy plant Sagar from reputed Manufacturer/ Authorized Supplier strictly in adherence to the detailed specification given in the Schedule II of the tender.

1.0 Instruction to Bidder/Tenderer

- (i) Bidder should read all terms & conditions of tender thoroughly before filling tender online.
- (ii) Scanned copy supporting document to be uploaded wherever required.
- (iii) Technical Bid, Form-A & Form-B shall be submitted online. Enclosed duly filled scanned copy to be uploaded.
- (iv) Price bid shall be filled online only. Physical form of price bid will be rejected out rightly.

2.0 EARNEST MONEY DEPOSIT

All the tenderers are required to deposit Earnest Money on line. As the tender will be finalized the unsuccessful tenderers will get back the EMD from MP TENDERS (as per their norms) on line. Submissions of earnest money by any other mode than specified above shall not be acceptable and the related tender shall not be eligible for consideration.

Scope of Work

Bidders Scope:-

- Bidder scope of work includes supply, installation, testing and commissioning of the butter blast
 Freezer room inclusive of PUF panels & Refrigeration units. As per detailed specification scheduleII.
- Unloading, Shifting and safe storage of cooling units & equipment etc at site.
- Providing 415/230 V, 50 Hz. Uninterrupted AC supply along with M.C.B. Switch for each refrigeration

unit& each blast freezer room light near (within 1 mtr. Radius) the condensing unit & cold room respectively.

- Out Door Stand will be bidders Scope.
- Protective shed for the condensing unit, along with MS stand for mounting it.

BkDS Scope:-

- Providing level base/floor (zero zero) for erection of butter blast freezer room.
- Water Drains points at site near butter blast freezer room.
- Adequate ventilation for the condensing / outdoor unit.
- Protective shed for the condensing unit, if necessary, along with MS stand for mounting it.
- Requisite racks for the cold storage.
- Any civil work if required.

5.0 Delivery Period

Material supply , installation & commissioning and trial run Within 3 months from the date of confirmed purchase order

6.0 Warranty

Subject to terms of payment agreed upon being punctually complied with and the equipment being operated properly, the machinery conversed by this contract carries a Warranty against manufacturing defects for 15 months from the date of supply or 12 months from the date of installation, whichever is earlier. If any part of the equipment is put by supplier earlier for any reason whatsoever, the warranty period will commence from the date of such use

Bidder agree to repair / replace such parts which may prove defective and which do not fail from neglector misuse or faulty operation. The defective parts should be replaced by bidder, duly insured and freight prepaid for examination and agreement that they are defective. The return freight and insurance charges on such repaired or replaced parts will be born by the bidder. No charge will be paid by us for work involved in the repair or replacement of defective parts during the Warranty period in the case of installations within the Municipal limits of any city where we have our own Branch or Service Center.

PRICE

Price offered by the tenderers should be firm and free from all escalations. The prices offered should be valid at least for a period of 12 months from the date of approval of rates; we would communicate our rate approval within 30 days of opening of tender only to successful tenderer.

The tenderer should quote rate only F.O.R Sagar dairy plant.

Octroi duty, if applicable at the destination, shall be borne by the supplier.

TENDER OPENING

Tender will be opened online on scheduled date and time in front of tender committee and representative of tenderer.

Online Technical Bid will be opened first & only on verification of technical bid & supporting documents, online price bid will be opened.

Price bid of only those tenderers shall be opened who fulfill all criteria of technical bid successfully.

ELIGIBILITY CRITERIA

- Tenderers should submit supplier's List with contact detail/Purchase order copy/performance Report.
- The tenderers should submit copy of IT Return for Last Three Financial years (2020-21, 2021-22, 2022-23).
- The tenderers should submit copy of PAN Card & GST.
- The tenderers should submit Filled Form-A & Form-B & attached related document as per Form A &B
- The tenderers should submit copy of Firm Registration certificate.
- The tenderers should submit At least one completion certificate copy of similar nature of work done by tenderer in recent years.

PAYMENT

- 40% advance against submission of bank guarantee of equivalent amount of contract value.
- 30% after supply of all required material for said work and installation at site.
- 20% after commissioning and successful trial run of machine at site and Balance 10% after submission of Performance Bank Guarantee (Nationalized Bank) of 10% equivalent amount valid for 12 monthsfrom the date of successful trial run of machine.

GENERAL TERMS AND CONDITIONS

The acceptance of the tender and award of the purchase order will be the sole right of the CEO Bundelkhand Sahakari Dugdha Sangh Maryadit, who does not bind himself to accept a tender in whole or part or reject any or all the tenders received without assigning any reason and no explanation can be demanded of the cause of rejection of the tender by any tenderer. If the tenderer fails to make supply within the stipulated time mentioned in purchase order, then they may be black-listed and EMD also may be forfeited.

- Negligence on the part of tenderer in filling the tender offers no right to withdraw the tender after it has been opened.
- The tenderers should send their offers along with detailed technical specification, necessary documents etc. which will form the basis of tender and integral part thereof.
- The CEO Bundelkhand Sahakari Dugdha Sangh Maryadit reserves the right to place order for sole requirement with any tenderor or split the orders among one or more tenderers.
- The tenders received against the advertisement upto the specified time limit only shall be considered. The Bundelkhand Sahkari Dugdh Sangh shall not be bound to accept lowest rate tender.
- The submission of a tender by a tenderer implies that he has read the notice and conditions of the tender and the terms and conditions of contract and has made himself aware of scope and specification of the suppliers to be made and the destination where the supply have to be made and satisfied himself regarding the quality and specifications of the articles.
- The tenderers should submit tender in online format only.
- No person or firm is permitted to submit more than one tender under different names.
- The conditional tenders are liable to be rejected.
- Each page of the technical Bid and its enclosure should be signed & sealed at the bottom by the tenderer.
- The supplier shall not sublet the supply or assign to any other party or parties, the whole or any portion of the contract.
- Required utilities like air, electric supply, soft water supply will be provided at only one point /Control power for above system by BkDS.
- The successful tenderer has to execute an agreement with this office on non-judicial stamp paper of Rs.1000/- within 10 days after allotment of work.

LIQUIDATED DAMAGES

The time period and the date of delivery of the material/services stipulated in the purchase/work order shall be deemed to be the essence of the contract. Once firm delivery date(s) are fixed for supply of material, they shall be strictly adhered too. In case they are not followed or in case of delay in execution or non-execution of the order, the Dugdh Sangh reserves the right either to cancel the order and make alternative purchase/ arrange the completion of job from other sources, at the risk and cost & expense of the defaulting supplier. In case the supplies & services are not fulfilled as per the schedules, the liquidated damages may be charged on the goods/ services not so delivered as under:

DISPUTE ARBITRATION & FINAL AUTHORITY
